• Operations in Poland

KPHG is based in Poznań, Poland – currently the largest fur farming country in Europe. This strategic location is recognized for its strong infrastructure and well-established logistics network, ensuring efficient transport of goods and convenient access for auction visitors.

• KPHG Investors

KPHG investors are coming from the retail trade in China and HK. They are mostly second generation in the fur trade.

• Same Grading Standard

KPHG will be using the Copenhagen Fur grading system at the same standard the trade have known and appreciated - to the benefit of both Farmers and Customers.

To ensure this, the grading will be conducted, managed and controlled by former members of the Copenhagen Fur quality and grading team.

• Same Auction Format

KPHG auction will be conducted like Copenhagen Fur did. Same principles and same auctioneers, only the currency (EUR) and location (Poznań) has changed.

• Better Farmer Condition

KPHG offers attractive farmer conditions. We charge 0.7 EUR per skin for service/grading/sales fee from farmers as this is our estimated cost price without fixed assets cost. If the end price ends up being cheaper, we will reimburse the farmers. If we end up with higher cost price, we will cover it by our-self and the 0,7 will prevail. Also, we offer pelting and skin advance at competitive market interest rates and conditions based on individual needs.

• On-demand Farmer Service

KPHG focus on the famer includes farm service assistance for example pelting advance/control, live-stock grading, farm management and farm visit, feed advice, vaccine solution and all other issues that may occur.

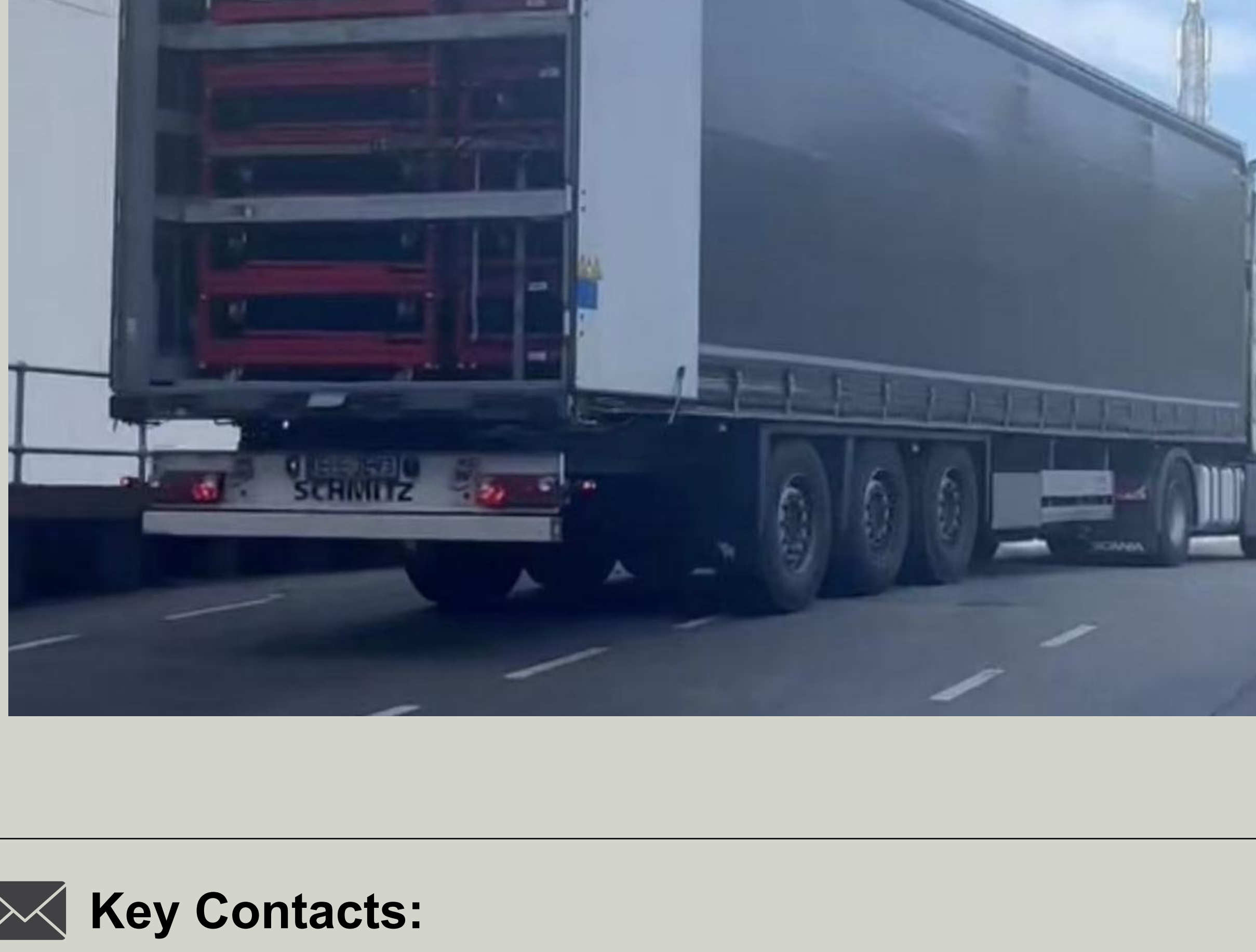
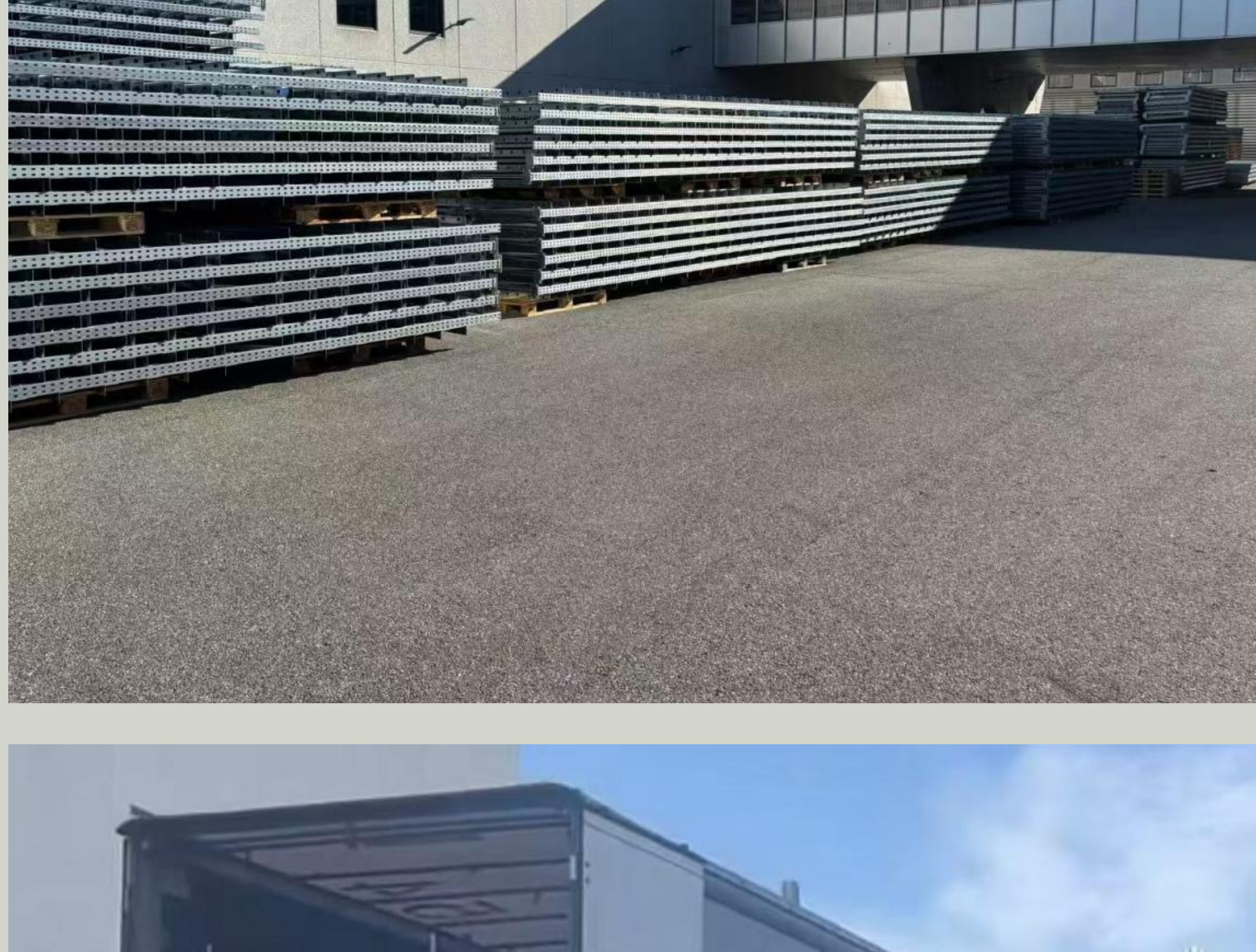
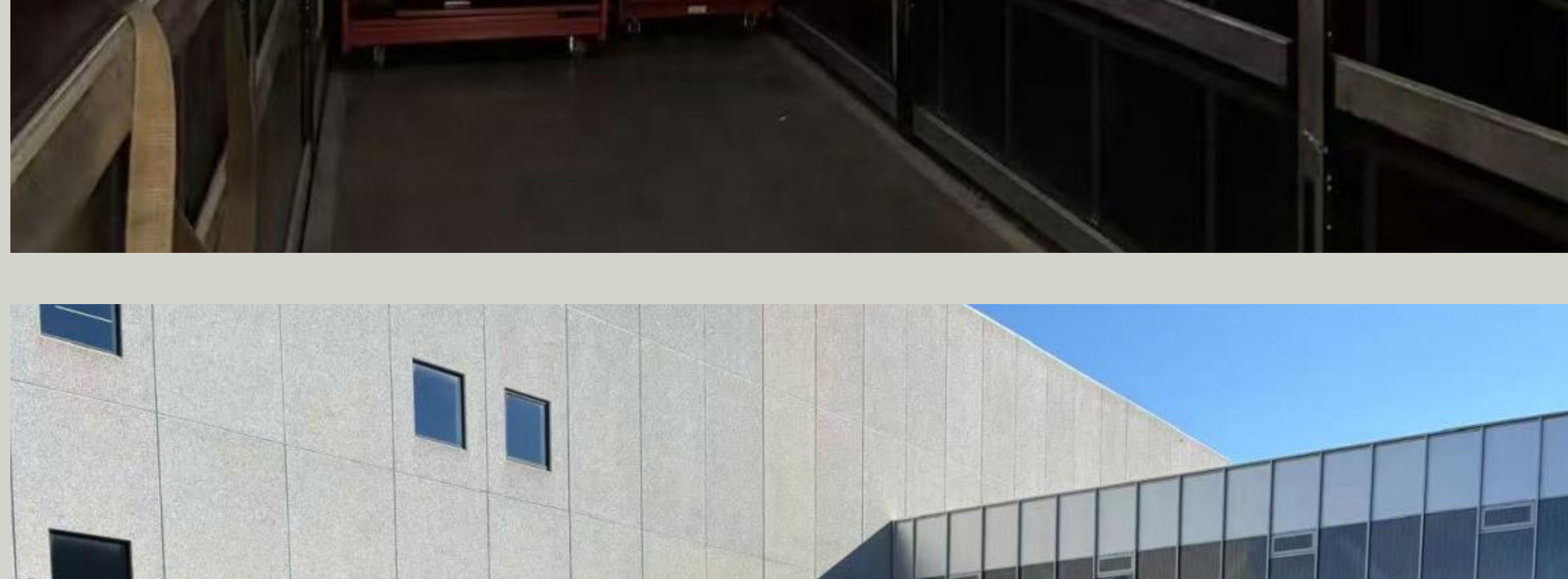
• Up-to-date Business Intelligence Information Sharing
